

RELEASE AND WAIVER OF LIABILITY; ASSUMPTION OF RISK AND INDEMNITY AGREEMENT; AND DIGITAL, FILM, VIDEO IMAGE RELEASE

This Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement, and Digital, Film, Video Image Release (the "Agreement") asks you to waive important legal rights. Before entering and agreeing to participate in "PAW-sitive: Interactive Art for Pets by Wellness" at the SOTA Art Gallery (the "Event"), please read and agree to the terms of this Agreement.

Upon endorsement of this Agreement, and in consideration for being permitted to participate in the Event, I and/or we, the undersigned, and my and/or our personal representatives, heirs, and next of kin ("I" or "ME") agree to the following:

1. **I HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE** WellPet Asia Pte Ltd and its directors, officers, agents, affiliates, employees, representatives, successors, along with each of their respective partners, sponsors, promoters, and volunteers involved in the planning and execution of the event (collectively referred to as the "Released Parties"), FROM ALL LIABILITY TO ME, and to MY personal representatives, assigns, heirs, and next of kin FOR ANY AND ALL LOSS, DAMAGE OR COSTS, INCLUDING LEGAL FEES, AND ANY CLAIM OR DEMANDS ON ACCOUNT OF INJURY TO MY PERSON AND/OR MY PET(S) OR MY DEATH AND/OR THE DEATH OF MY PET(S) ARISING OUT OF OR RELATED TO THE EVENT, WHETHER CAUSED BY THE ACTIONS OR INACTION OF THE RELEASED PARTIES OR OTHERWISE.
2. **I HEREBY AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS** the Released Parties and each of them FROM ANY LOSS, LIABILITY, DAMAGE, OR COST they may incur arising out of or related to the EVENT, WHETHER CAUSED BY THE ACTIONS OR INACTION OF THE RELEASED PARTIES OR OTHERWISE.
3. **I HEREBY ASSUME FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH** to ME AND/OR MY PET(S) arising out of or related to the EVENT, WHETHER CAUSED BY THE ACTIONS OR INACTION OF THE RELEASED PARTIES OR OTHERWISE.
4. **I HEREBY AGREE TO FOLLOW ALL OTHER RULES AND REGULATIONS** with regard to the Event as established by WellPet Asia Pte Ltd for the Event.
5. **I HEREBY AGREE** that this Agreement is intended to be as broad and inclusive as is permitted by the laws of Singapore in which the Event is executed and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
6. **I HEREBY GRANT** to WellPet Asia Pte Ltd, and its agents, representatives and successors the absolute and irrevocable right and unrestricted permission in respect of photographic portraits, pictures, film, video or any other media taken of or showing ME AND/OR MY PET(S) or in which I AND/OR MY PET(S) may be included with others relative to the Event, to copyright the same, and without compensation to use, reuse, publish and republish, distribute and redistribute, reproduce, display, alter without consent or approval, and create derivative works of the same in whole or in part, individually or in conjunction with any other media, now or hereafter known, including web pages and social networking media, for any other purpose whatsoever, including, without limitation, for illustration, promotion, art, editorial, advertising and trade, or any other purpose whatsoever, from time to time. ,
7. **I HEREBY GRANT** to WellPet Asia Pte Ltd, and its agents, affiliates, representatives and successors the absolute and irrevocable right and unrestricted permission to photograph, video, record, in any manner or media, ME or my Pet(s) at the Event without compensation or approval rights, in each case, in connection with the Event.



I HAVE READ THIS AGREEMENT. I FULLY UNDERSTAND ITS TERMS, AND UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT. I FULLY UNDERSTAND THAT BY SIGNING THIS AGREEMENT, I FREELY AND VOLUNTARILY GIVE UP MY RIGHTS TO ANY FUTURE CLAIMS OF LIABILITY AGAINST THE RELEASED PARTIES FOR ANY BODILY INJURY, OR DEATH TO ME AND/OR MY PET(S) THAT MAY RESULT FROM MY PARTICIPATION IN THE EVENT. I HAVE SIGNED THE RELEASE SET FORTH IN THIS AGREEMENT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTEE BEING MADE TO ME AND INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE TO THE GREATEST EXTENT ALLOWED BY LAW.
